**Re: Beds in Abeyance at Extendicare Bayview**

I am writing regarding the request from Extendicare (Canada) Inc. (the "Licensee") to extend the agreement of the two (2) beds in abeyance (BIA) at Extendicare Bayview (the "Home").

I can confirm that the current agreement that expires on June 30, 2025, will be extended until June 30, 2028.

The extension of the agreement for the 2 beds at the Home will continue to be subject to the terms and conditions set out in the letter dated October 7, 2011 (referred to as the "Agreement").

By April 1, 2027, the Licensee shall submit to the ministry a plan to return the beds to operation. This plan can be approved by way of an executed development agreement or another method agreed on by the ministry.

Thank you for your on-going efforts in the delivery of long-term care services in Ontario.
